General comments

Question 1: Do you have comments on the overall draft of the SEEA Ecosystem Accounting?

The *Millennium Ecosystem Assessment Report* (2005) included 'sense of place' as a cultural ecosystem service in its own right, recognising that sense of place is part of the contributions made by ecosystems to human society which need to be assessed and managed.

'Sense of place' is not referred to in the overall draft of the SEEA Ecosystem Accounting, but it is similar in concept (I presume) to spiritual or symbolic services, which appears to have been addressed as a non-use values.

Within non-use values they would be more closely aligned with existence value.

The current proposal for SEEA Ecosystem Accounting is to exclude those values.

Particularly in the Australian context, this is quite problematic as it does not account for the indigenous peoples' Connection to Country, and the role that their activities and Caring for Country play in maintaining the health and condition of ecosystems, which thus provide other ecosystem services.

I would imagine there are other First Nations people which have similar connection to their country and caring for their country activities.

If this cannot be addressed as part of this proposal for SEEA Ecosystem Accounting, then a recommendation should be made that this issue be urgently addressed as a separate companion piece of work to inform SEE-EA.
