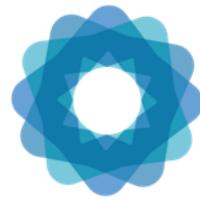

Questions related to Chapter 6

Question 1: Do you have comments on the concepts and definitions for ecosystem services, benefits and associated components of the ecosystem accounting framework?

The section on concepts and definitions is quite clear; however, to distinguish SNA and non-SNA benefits, I thought it would be better to make use of the former as *economic benefit* throughout.

There are no comments regarding concepts and definitions, they are well put

Question 2. Do you have comments on the content and descriptions in the reference list of selected ecosystem services?

Well defined, especially since it is clear that the reference list is not exhaustive and that countries would still need to come up with their country-specific list while still observing the internationally agreed classification system.

The contents and description in the reference list is clear though some services are not relevant to the country

Question 3. Do you agree with the proposed treatments for selected ecosystem services described in Section 6.4 for biomass provisioning services, global climate regulation services, cultural services, water supply and abiotic flows?

Lesotho uses biomass primarily for the purposes of energy; therefore, the gross quantity of biomass that is harvested would be complex to align with the measurement of the ecosystem services. It would be challenging to obtain quantity of grazed biomass.

Biomass in Lesotho is mainly for energy purposes. I think the **Gross** quantity of biomass that is harvested would be a bit tricky to align with the measurement of the ecosystem services. Also quantity of grazed biomass might not be easy to obtain.
