The topic of a potential update to the SEEA Central Framework will be discussed during this session, as will the current state of play of the SNA revision and ISIC and CPC updates.

**9:00 – 10:30: Area B2 - SEEA Ecosystem Accounting** (Area lead: Eurostat)  
The session will discuss the proposed implementation strategy for the SEEA Ecosystem Accounting, including potential priorities and governance mechanisms. A data interoperability strategy for ecosystem accounting will also be covered.

Presentations will be given on the UNECE Task Force on Circular Economy and the Global Set of Climate Change Statistics and Indicators. Discussion will focus on how to advance the SEEA in these areas and the role of the Committee. The session will also include an analysis of the different groups and initiatives working in the environment statistics space.
