# Terms of Reference for Senior Business and Sustainability Accounting International Consultant

Project "Natural Capital Accounting and Valuation of Ecosystem" United Nations Statistics Division/DESA

### **Background and Objectives:**

The Project "Natural Capital Accounting and Valuation of Ecosystem Services" (NCAVES) has been established to advance the knowledge agenda on environmental-economic accounting, particularly ecosystem accounting, by initiating pilot testing of the System of Environmental Economic Accounting Experimental Ecosystem Accounting (SEEA EEA) in five strategic partner countries to the European Union (EU), namely Brazil, China, India, Mexico and South Africa. The United Nations Statistics Division (UNSD), the United Nations Environment Programme (UN Environment) and the Secretariat of the Convention on Biological Diversity are the implementing agencies of the European Union funded project NCAVES.

The main objectives of the project include: (a) improving the measurement of ecosystems and the services they provide (both in physical and monetary terms) at the (sub)national level; (b) mainstreaming biodiversity and ecosystems in (sub)national level policy-planning and implementation; and (c) contributing to the development of internationally agreed methodology and its use in partner countries.

As part of the objective to mainstream ecosystem accounting and promote its use in partner countries, the project also includes a workstream on business accounting. This workstream aims to: 1) contribute to the alignment of natural capital accounting between the public and private sectors; 2) understand the data needs of the companies and explore how to harness synergies between the public and private sectors in the collection and use of statistics and data for natural capital accounting; 3) provide a technical methodological contribution at the level of methods or of indicators that promotes alignment.

To reach these objectives, there is a need to bring together the public and private sectors to look at the synergies of business accounting and the SEEA, particularly with regards to ecosystems and ecosystem degradation and restoration. A scoping workshop has taken place in October 2019 in New York, and a draft roadmap has been developed. The objective of this consultancy is to develop the short-term objectives of this roadmap including working with selected companies on case studies, contribute to the organisation of a second workshop, and design an outline for a guidance document on NCA for companies.

#### **Work Assignment:**

The consultant would undertake the following tasks:

### Activity 1: Develop short-term objectives of the roadmap

- Identify a minimum of 3 case studies in total with companies that have expressed interest; preference will be given to case studies within NCAVES project countries
- Agree on the scope of work for each case study and validate in clear Terms of Reference;
- Familiarize with the natural capital assessment and/or accounting approaches by each company and the type of national level natural capital data (this is necessary for being able to deliver solid expert advice to companies)



- Provide expert advice for the participating companies and coordinate the efforts by all involved stakeholders, organize and chair meetings using video-conference services, assess data (company data, NSO data) in terms of alignment potential, etc.
- Prepare case study reports with description of the activities that have been piloted, and the results
  including lessons learned in terms of alignment between public and private natural capital
  accounting.

## Activity 2: Contribute to the organization and execution of the 2<sup>nd</sup> workshop on business accounting

- Develop a draft agenda for a second workshop
- Develop a detailed annotated agenda, including suggested speakers;
- Liaise with speakers for the workshop to ensure that workshop objectives will be met
- Review the presentations/materials to be delivered at the workshop during the duration of the contract:
- Participate in the workshop as a resource person
- Present and chair/moderate during select sessions of the workshop;
- Work with the UNSD communications consultant to identify appropriate communications outlets
  and opportunities around the event and more broadly on the application of the SEEA for
  corporate reporting or use of SEEA for contextual information by companies.
- Prepare a workshop report

#### Activity 3: Develop an outline for a guidance document for companies interested in NCA

- Based on the results of activity 1 and 2, develop an annotated outline for a guidance document for companies with an interest in applying the SEEA EEA, describing how the SEEA EEA can be used to support company-level decision making and reporting;
- Include a draft glossary
- Update the roadmap

#### **Activity 4: Outreach:**

• Participate in events to promote the NCAVES business work (e.g. IUCN World Congress)

#### **Duration of contract**

50 days over the period of 1 February 2020 to 30 August 2020.

#### **Duty station or Location of Assignment**

The consultant is expected to work remotely from his/her residence and will be available for regular phone and web conference meetings with UNSD staff members during office hours.

#### **Travel**

International travel will be required for the Consultant to participate in the second workshop and for outreach activities. Round trip transportation from the consultant's official address, daily subsistence allowance (DSA) and terminal expenses will be provided in accordance with UN travel entitlements. Travel costs will be obligated separately.
