## Main conclusions from the Oslo Group with relevance to the London Group

- Energy statistics need to be consistent with other statistical systems and use/coordinate between the different statistical systems.
- There should be one international standard on energy statistics, balances and accounts which will be based on the System of National Accounts, with some deviations if and when necessary.
- The development of a multipurpose statistical system is the goal. This would enable various user needs to be met and compilation tables for different purposes to be generated. User needs with supporting information about reporting tables need to be communicated adequately to the Oslo Group.
- The Oslo Group will provide input into the UN's revision of the UN energy statistics manuals.
