AREA C: Global databases – Roadmap and remaining questions

Main progress since 2017 UNCEEA

- **Going global and filling gaps**
 - Good progress with methods to estimate accounts for missing countries
 - Methods mature or close to mature, and ready for being applied
- **Getting prepared for data exchange: development of DSDs**
 - Good progress under the lead of Eurostat
 - Managed by a sub-group of the SDMX macroeconomic statistics ownership group (SDMX-MES OG)
 - Testing and review forthcoming
- **Making data available**
 - Progress with material flow data; land cover data
- **Working together**
 - International institutional arrangements for the production of global SEEA accounts (collection, compilation, estimation): well defined; some clarification needed
 - Other aspects: to be further clarified

The case of water accounts

- **No progress so far**
 - Limited data availability; many data quality issues
 - Low interest in some countries (EU)
- **International collection and production of water data well established**
 - OECD/Eurostat and UNSD/UNEP coordinated questionnaires
 - quasi-global coverage; ISIC breakdown for key variables; partially building on accounting principles (resources, abstraction, supply & use, wastewater)
 - FAO Aquastat: database (and new questionnaire)
 - Link to SDG indicators
- **Discussions on harmonised international questionnaire and collection process initiated to avoid duplication**
 - OECD/Eurostat/UNSD with FAO
- **Proposal to review feasibility at next UNCEEA meeting (2019)**
 - Build on SEEA-Water and Technical notes
 - Build on earlier review of questionnaire(s) and current response rates





AREA C: Global databases – Roadmap and remaining questions

Quality assurance and validation principles

- **Data collected from countries**
 - Use QA and validation processes with countries already in place.
- **Data not or not yet collected from countries and estimated**
 - Apply *harmonised methodologies* that benefit from an international consensus, i.e. endorsed through a formal process by UNCEEA/SEEA-CF TF
 - Use commonly *agreed upon validation processes*, e.g. make the estimates available to countries for review, documentation and possible amendment before release
- **All data: apply principle of *mutual recognition***





AREA C: Global databases – Roadmap and remaining questions

Dissemination and communication

- **Documentation**
 - Underlying data sources, compilation methods, validation criteria
 - Distinction between official country data and estimated data
 - Using flags or releasing “official” and “estimated” data in two separate datasets
- **Access (short term)**
 - Via statistical platforms of involved agencies
 - Cross-referencing among SEEA databases
 - Establishment of a dedicated webpage (portal) on SEEA website
- **Access (longer term)**
 - Envisage creation of **consolidated SEEA databases** combining several selected SEEA related datasets using a common structure and industry breakdown

- **Following the UNCEEA meeting**
 - Review and finalise proposed roadmap (Area lead with group members)
- **Before end 2018**
 - Further clarify institutional and work arrangements (Area lead with group members)
 - Data collection, compilation, estimation
 - Data quality assurance and validation
 - Data dissemination and communication
- **In 2019**
 - Clarify/specify technical arrangements for data exchange (Area lead and Eurostat, with group members)
 - Initiate discussion on data ownership and copyright arrangements (Area lead with group members)
 - Prepare scoping note on global SEEA core water accounts
- **Any other steps to be considered?**
