Introduction

Area A - Area lead Statistics Canada

Area A will continue to play a role in its traditional space of fostering communication and coordination by meeting regularly, discussing key initiatives, and identifying emerging issues. The main activities planned include finalization of a landscape assessment of the different groups/initiatives relevant to the Committee's work and the initiation of a webinar series on policy-related applications of the SEEA. The landscape assessment will serve as an input in identifying existing activities and foster synergies. Further the webinar series will focus on particular policy domains and will have the objective to bring together different stakeholders. The specific activities and a tentative timeline are below.

At its sixteenth meeting, held in 2021, the Committee recommended that a discussion begin on a possible update of the SEEA Central Framework (SEEA CF), to take place during the Committee's eighteenth meeting, in 2023 in the light of the update of the System of National Accounts 2008, the adoption of the SEEA Ecosystem Accounting and the progress of the research agenda of the SEEA Central Framework. Pending on the outcome of the discussion, the main activity for Area B1 for the medium term is to set up a work programme and identification of the funding mechanism for the inprinciple update of the SEEA CF. The proposed specific activities and a tentative timeline are below.

The Technical Committee has reviewed its terms of reference and is considering expanding its membership to better reflects the needs to support the development of methodologies for the implementation of the SEEA EA. A detailed programme of work is being developed, and what is presented below is a preliminary draft. The committee will continue to meet every two months to discuss specific technical issues with the objective of developing guidance notes for supporting the implementation in countries.
