**ENVIRONMENTAL-ECONOMIC ACCOUNTING FOR EVIDENCE-BASED POLICY
IN ASIA**

This e-Learning programme is organized by the United Nations Statistics Division (UNSD), in collaboration with the UN Economic and Social Commission for Asia and the Pacific (ESCAP). It provides an overview of the System of Environmental-Economic Accounting (SEEA) Central Framework (CF) and how it can be used for sustainable policy decisions. The e-Learning programme is directed towards select countries in Asia which have active SEEA programmes. In particular, the programme is aimed towards users and producers of SEEA accounts, with a focus on users of the accounts.

The training programme encompasses two different modules: 1) An introduction to the SEEA Central Framework and 2) a module on the policy applications of the SEEA, geared towards users of the accounts, with a short introduction on the SEEA and chapters on biodiversity, climate change and macroeconomic/finance applications.

This e-Learning, funded by BMZ and supported by GIZ, was part of the Enhance NCA Policy Uptake and Relevance (EnhaNCA) project, which provides materials to increase policymakers' understanding of the applications of NCA according to the SEEA. PROGRAMME OBJECTIVES

- Develop a general understanding of the SEEA conceptual framework;
- Build knowledge on the policy applications of the SEEA, particularly for biodiversity, climate change and macroeconomic/finance policies; and
- Learn how different countries have used the accounts to strengthen policy-data links.

EXPECTED PROGRAMME OUTCOMES

By involving policy makers and data users from line ministries, as well as producers from national statistical offices, the programme seeks to develop shared understanding and appreciation of the value of the SEEA accounts among key stakeholders.

The programme is designed to enable participants to take the following actions in their respective national context:

- Convene multi-agency stakeholders to develop a plan for the production and use of SEEA accounts.
- Better communicate results of existing SEEA accounts, highlighting policy applications of the SEEA for biodiversity, climate change and macroeconomic policies; and
- Improve the use of the accounts in development and monitoring of national environmental policies and reporting for international frameworks.

TARGET AUDIENCE AND PARTICIPANTS

The target audience for the e-Learning includes representatives from select countries in Asia, in particular:

- Policymakers and users of the accounts, including representatives from ministries of environment, natural resources, planning, finance, etc.
- NSO staff engaged in consultation with users of NSO products and services
- Producers of environmental and economic statistics and accounts
