I. COFOG Overview & Timeline



COFOG Overview

Classification of the Functions of Government (COFOG)

Part of the set of Classifications of Expenditure According to Purpose, which also includes:

Classification of Individual Consumption by Purpose (COICOP)

Classification of the Purposes of Non-Profit Institutions Serving Households (COPNI)

Classification of the Outlays of Producers by Purpose (COPP)

Approved by the UN Statistical Commission in 1999 (E/CN.3/1999/29).

Currently undergoing a revision process

Presently governments classify their public expenditure using COFOG, which is an international standard classification that organizes public government expenditure into functional categories of interest to policy makers





COFOG Overview

Task Team on the Revision of COFOG (TT-COFOG)

Experts and representatives from various communities (e.g., classification, government finance, environment, subject matter experts) from 15 countries & 10 international/regional organizations

Five initial TT-COFOG meetings held since April 2024

- Collected proposed revision issues from Task Team members from April September 2024
- Developed the revision issue category list and questionnaire for the global consultation
- Agreed to divide revision issues into 5 Working Groups



Revision Timeline

*UNSC submission moved from 2027 to 2028 to align with GFSM and SEEA CF update processes

Consultation on Initial List of Issues (November 2024 - January 2025)

- 105 responses from 74 different countries and 8 organizations
- Wide-ranging interest in joining Working Groups
- Majority of respondents noted support for consideration of 19 of the 21 issue categories, in particular:
 - Environmental Protection
 - Economic Affairs
 - General Public Services
 - Health
- All 21 issue categories deemed either high or medium priority among a majority of respondents, in particular:
 - Environmental protection
 - COFOG structure/classification principles
 - Health
 - Compilation issues
 - Internal consistency w/other classifications of expenditure according to purpose

Respondents invited to provide any comments on the issue categories

- Comments providing additional proposals or information
- Comments expressing reservations or concerns with initial proposals

These comments have been organized by issue within each Working Group; can act as a starting point for discussions

- Expected that Working Groups will meet up quarterly, with email exchanges in between
- Given the number of interested participants, only current TT-COFOG members to be invited to Working Group meetings; issue notes and outputs are planned to be shared with others
- Seeking experts to volunteer to take the lead in drafting proposals for selected revision issues

Work plan stages for Working Group B

4 Stages

- Stage A: Discuss / confirm the scope of the environment(al protection) division
- Stage B: Discuss the structure i.e. subclasses of the division
- Stage C: Discuss definitions / scope of subclasses including borderline issues
- Stage D: Discuss descriptions of all subclasses

- A05.7 Review issue of biodiversity

Stage C: Waste, Water and Air Pollution (Seeking volunteers)

- A05.5 Clarify the classification of water-related expenditure
- A05.8 Split Group 05.1 Waste management
- A05.9 Consider split of Class 05.3.0 Pollution abatement and improve description of 05.6.0 Environmental Protection n.e.c.
