#### **Overview**

- UNSC at its 52<sup>nd</sup> session endorsed the recommendation of the Expert Group on International Statistical Classification to revise ISIC Rev. 4 and CPC Ver. 2.1 (See E/CN.3/2021/30)
- Separate Task Teams on ISIC and CPC have been formed to conduct the revision process
- The UNCEEA community was invited to participate in the two task teams to contribute to the revision process by:
  - Providing input to existing classification issues
  - Identify a list of additional SEEA-relevant classification issues for consideration



#### **CPC** revision schedule

#### ☐ Timeline

- Mar 2021 UNSC mandates the revision of CPC
- Sept-Dec 2021 conduct a global consultation to collect issues with the classification and review results of that consultation
- Jan- Dec 2022 Develop a complete draft structure of the revised CPC and conduct a global consultation on the revised CPC
- Mar 2023 adoption of the revised CPC by the UNSC.
- ☐ First task team meeting conducted (25 August); meetings will be conducted once every 3-week time for the remaining of year to advance the revision



#### Main drivers of CPC revision

- Identifying digital goods and assets
- Adapting to current global trade (specialized versus non-specialized products)
- Addressing global environmental and social issues (green economy and humanitarian, health
  - and safety products)
- Addressing protection of society and the fight against terrorism
- Addressing technological advances (fibre, metal forming machinery)
- Addressing goods specifically controlled under various Conventions



#### **SEEA-related issues for CPC revision**

#### ■ SEEA-relevant issue on the list:

- Addressing global environmental and social issues (green economy and humanitarian, health and safety products) is considered as one of the main drivers of CPC issues
- Account for environmental products and services in either new or existing categories is considered as one
  of the issue to be addressed
- Review underlying principles, application and use of CPC
- Definition of goods, services and products

#### ☐ Specific SEEA issues identified

- Better reflection of energy products and alignment with the Standard International Energy Product Classification (SIEC)
- Review links of CPC and the Classification of Environmental Activities
- Review treatment of waste in CPC

#### Carbon capture and storage in subsoil

With regard to **carbon capture and storage** in the subsoil the proposal is to create a new class, there are several options where this would fit in ISIC:

- a) In Division B "Mining and quarry", based on the technical nature of this activity it probably is best put under this division. It could be a new group under Division 09, namely Group 092 "carbon capture and storage". However, it is noted that i) carbon capture and storage as such is not mining (taking natural resources out of the ground) and ii) also not directly a supporting activity for other mining activities.
- b) In ISIC O "Public administration and defence; compulsory social security", an option is to create a new class under Group 841 "Administration of the State and the economic and social policy of the community' or Group 842 "Provision of services to the community as whole". However, based on the technical nature of the activity, the question is whether it could be put under the provision of public administration services.
- c) In ISIC Q "Human health and social work activities", an alternative option is to create a new Group in the sense that they are services provided for the collective common good (i.e., climate change mitigation), although it does not really seem to fit under Division 86, 87 or 88.
- d) Other proposal on how to reflect such activities in ISIC is welcome.



#### Carbon sequestration and carbon storage in biomass

With regard to activities related to **carbon sequestration and storage in biomass**, a new class could be created, or this activity could be included in one of the existing ISIC classes (with the proper description in the explanatory notes:

- a) Inclusion in Class 0161 (Support activities for crop production),
- b) Inclusion in Group 021 (Silviculture and other forestry activities),
- c) Inclusion Group 813 (Services to buildings and landscape activities) or in the new group 814 ecosystem management (to be proposed in the other note).
- d) Other proposal on how to reflect such activities in ISIC is welcome.
